#### Purpose of the FLA-PAC Dianne Hill Scholarship:

- 1. The applicant must be an Accreditation Manager or Accreditation Specialist who is employed by an accredited agency/department that is a current member of the Florida Police Accreditation Coalition, Inc. (FLA-PAC) and has all the qualifications required in the CAP Application.
- 2. The selection of the winner shall be made by the FLA-PAC Scholarship Committee.
- 3. In order to qualify for consideration, all applications and materials must be submitted by e-mail to:

- 4. The scholarship winner shall receive notification by e-mail or regular mail.
- 5. The award check will be presented to the winner by the FLA-PAC President at the February Conference.
- 6. The scholarship essay must be typed and a copy of the letter from the CAP Committee must be attached showing that the applicant to the FLA-PAC Dianne Hill Scholarship has met all requirements to receive the CAP designation.
